- i. Detailed Terms & Conditions are mentioned in RFP Document.
- ii. **Single Stage Two Envelope** Bidding Procedure will be adopted, as per Rule 36(b) of the PPRA Rules.
- iii. It is mandatory for proposals to be prepared using standard forms of the RFP Document Issued by HESCO.
- iv. The Prices should be firm and final without involving any foreign exchange.
- v. Bid Security equivalent to Rs.500,000/- (Rs. Five hundred thousand only) should be placed in the Technical Proposal.
- vi. RFP Document can be obtained from the office of DG/HR & Admn: Director HESCO, Room No 118, WAPDA offices complex, Hussainabad, Hyderabad against non-refundable amount of Rs.3000/- (Rupees three thousand only) on any working day during office hours, till a day earlier from the opening of the proposals.
- vii. There will be no sale of RFP Document on the date of opening of proposals.
- viii. RFP Document will be received manually and dropped in the tender box before the deadline of submission of proposals. HESCO will not be responsible for RFP Documents received via courier / post after opening date & time.
- ix. The bidders must ensure that their bids/proposals are dropped in the tender box well in time.
