- iii. The HSE Consultant must have 12 (Twelve) year experience in Safety management, including Five (5) year experience in Power Sector.
- iv. The HSE Consultant will be selected under Quality and Cost Based Selection (QCBS) method in accordance with PPRA Rules 2004 and PPRA Procurement of Consultancy Services Regulations 2010; and as per procedure described in the RFP.
- v. It is mandatory for proposals to be prepared using standard form of the RFP Document issued by HESCO.
- vi. The Prices should be firm and final without involving any foreign exchange.
