The subject purchase order was placed upon your firm for supply of 500 Nos. Cell Phones, wherein following delivery scheduled was prescribed:

You have failed to deliver the goods within prescribed delivery schedule, in this regard several notices were served upon you for supply of subject material, but you failed to abide by your contractual obligations.

In the meanwhile, the concerned bank that had issued the Banker's Cheque confirmed that the pay order has 'already been cancelled'. Upon further enquiry from the bank, it was revealed that the Pay Order had been cancelled on fake signature of CEO HESCO.

This clearly reveals that you have not only committed breach of contract by not supplying the Cell Phones but also involved in fraudulent practice. Therefore, it has been decided by the Competent Authority to impose the following penalties upon your firm under Clause-15 under caption "Failure & Termination", Clause-18 under caption "Forfeiture of Security" and clause-19 under caption Laws Governing the Contract attracting PP Rule-19(1a) of the contract / Purchase Order:

- a) Purchase order No. 02-0037 dated 08.09.2022 is hereby cancelled.
- b) Pay Order submitted against subject purchase order issued by JS Bank Limited Qasimabad Branch Hyderabad bearing No.OSHP009313 dt: 04.05.2023 amounting to Rs.2,000,000/- valid for one year is hereby forfeited and confiscated in favour of HESCO, Hyderabad. This Pay Order was submitted, afresh, by you against the above Purchase order).

c) Your firm is Black-listed and henceforth cross debarred for participation in any public procurement or disposal proceedings for the period of 5-years from the date of issuance of this letter.
