- 3.Tender cost / Fee non refundable @ **Rs: 3000/- (Three Thousand Only)** for each NCB shall be deposit online in United Bank Limited, Bank **IBAN: PK34UNIL0112053601020410** of **Executive Engineer Civil Works Division Hyderabad** before bid closing time, Original Bank Receipt should be attached with Original CDR / Bank Guarantee of Bid Security.
- 4.All E-Bids must be accompanied by a Bid Security duly generated from firms own account should be in the form of pay order / CDR in favour of Executive Engineer Civil Works Division HESCO Hyderabad from any Scheduled Bank of Pakistan, valid for 28 days beyond bid validity date. The prospective bidders shall upload scanned copy of Bid Security on EPADS and Original Bid Security must be submitted to the Procuring Agency one day before opening date of e-bids, failing which the e-bids shall be rejected.
- 5.The bidder must demonstrate financial status as mentioned in bidding documents with requisite audit documents.
- 6.The bidder must provide atleast 02Nos: photocopies of work order alongwith completion certificates of same nature civil work, income tax returns for last three years and audited financial report of last three years from certified firm having professional (CPA) Certified Public Accountant.
- 7.The bidder shall not be black listed by DISCOs / NDTC/ PPMC/ PPRA or any other Govt Department.
- 8.The bidder must provide the all attested copies of eligibility and qualification criteria as mentioned in bidding document, otherwise the firm will be considered as non-responsive.
- 9.The most advantageous bidder shall submit Bank Guarantee (10% of contract amount) from any schedule Bank of Pakistan before award of work.
10. Under rule 33(1) of PPRA Rule 2004, the HESCO Authority reserves the rights to accept or reject any or all bids or proposals at any time prior to acceptance of bid or proposal.
