- The eligible firm must have completed at-least two contracts of same nature along with its completion successfully as main contractor within ten years. The consolidated value of these contracts must be more than or equal to estimated / BOQ cost.
- All bids must be accompanied by a bid security in favour of Project Director GSC HESCO Hyderabad having name of firm on CDR from any scheduled bank. The firms who will participate as J/V should submit CDR from joint account and should be registered with FBR.
- The eligible firms should submit written request along with attested copies of CNIC, PEC License, at least 02 No. valid work orders of Transmission Line works and other requisite documents.
- Bidding document can be obtained from the office of Project Director GSC HESCO Hyderabad WAPDA (Water Wing Colony) Hussainabad Hyderabad during office hours by eligible firms. Authority letter is required on 100 rupees judicial paper for contractor representatives to receive tender documents/ participation in tender. The firm will have to submit the affidavit on 100 rupees judicial paper in which the bidder undertake that the firm is not black listed from any organization; no any litigation with any department and all submitted documents are genuine. The bids will be opened at the office of Project Director GSC HESCO Hyderabad.
- The successful bidder will have to submit 10% of the contract price as performance security in the form of CDR OR Bank Guarantee.
- The Deadline date for issuing the bidding document is one working day before opening date. Price of bidding document is Rs. 4000/- each (Non refundable).
